The Project

It is vital that a just transition in line with the European Green Deal is at the heart of the recovery from the pandemic crisis. **This project aims to help trade unionists benefit from the opportunities this recovery brings to promote a sustainable future with high employment levels for their company or industrial area through social dialogue**, by formulating and supporting proposals in line with the philosophy of just transition. **Therefore, the main project objective is to supply knowledge, tools and working methods to local-level and/or company-level trade unionists in order to help them take steps to enable a just transition towards a carbon neutral and circular future for their production plants or production areas.**

5 Phases / 8 Working Packages

- 1 – Coordination and monitoring (WP1)
- 2 – Research and exchange of information (WP2-WP3-WP4)
- 3 – Training (WP5)
- 4 – Test of the outputs (WP6)
- 5 - Dissemination (WP7-WP8)

Output: Tools

-**TOOLKIT** in English, Bulgarian, Dutch, French, Italian with guidelines on Just Transition

-**TEAM OF COUNSELLORS / HELP DESK.**

Two or three Just Transition Counsellors identified and trained for each partner involved. They will support trade unionists in collective bargaining in all aspects in close collaboration with the sectoral federations. Support for local trade unionist will continue after the end of the project through the creation of a helpdesk at central level that can be contacted by telephone, email or through in-presence meetings or videoconferencing.

TRAINING TOOLS AND METHODOLOGIES (national and transnational) for Just-Transition-Counsellors' training

-National grids with a comprehensive picture of the situation in each country involved in the project and some good practices on just-transition

-A short guide to be disseminated between trade unionists, which describes the possible support they can obtain from the team of counsellors and help desk



Dissemination

The objective is to **encompass the development of trade union strategies and good practices to advance just transition at company or sectorial level** to create visibility and reinforce the European trade unions, industrial relations systems and social dialogue.

At **European level**, the project will engage European institutions and the networks in which the applicants are involved (i.e. TURI networks) in order to maximize the impact of the project. At **national level**, the project findings will be disseminated through local networks and the partnership links.
